The migration included core workloads such as Exchange, SharePoint, and OneDrive, along with Intune-managed Windows devices. A like-for-like migration was essential to preserve productivity, ensure data integrity, and avoid unnecessary friction for end users.

- ✓ 9 SharePoint sites
- ✓ 68 OneDrives and devices
- ✓ 29 shared mailboxes
